The Society is managed by an Executive Committee. The quorum for an Executive Committee meeting is seven elected members at least one of whom shall be the Chair, Deputy Chair, Secretary or Treasurer. The Committee meets quarterly, with a formal record taken of each meeting. The Society also has a membership secretary, but this is not necessarily a recognised Committee post. Funds are set up by the committee, budgets set and a lead Committee member allocated to represent each Fund at Committee level, albeit the actual Fund 'project manager' may not necessarily be a committee member.

In order to maintain links with other related organisations such as BTO, RSPB and Wetland & Wildfowl Trust and local conservation officers, representatives of those organisations are invited to attend meetings of the Executive Committee where they may speak, but not vote, on any matters brought before the Committee.

The Society pays an annual subscription fee to Wiltshire Wildlife Trust.

All trustees give their time voluntarily and receive no remuneration or other benefits.

## Objectives and activities

The objects of the Society are:

- a. To encourage and pursue the study, recording and conservation of the birds of Wiltshire;
- b. To publish the more significant of its recorded findings;
- c. To co-operate with similar bodies, both local and national, in the foregoing objects.

In planning our activities during the year we kept in mind the Charity Commission's guidance on public benefit at our Committee meetings.

The committee uses a spreadsheet to evaluate potential projects against various criteria. The focus of our conservation activities during the year continued to be on Tree Sparrow and Raptor Monitoring.

We produced and published for the public benefit 'Hobby: The Wiltshire Bird Report', which was distributed to members and made available to the public for purchase.

We continue to organise and lead outdoor meetings, visiting new and/or varied habitats (not just in Wiltshire) to encourage and broaden knowledge understanding of species and habitat. Our indoor meetings are focused around guests speaking on a range of various ornithological/nature/wildlife subjects.

We welcome members from across the country (not just limited to Wiltshire) adults and junior, who are encouraged to bring guests to our Indoor and Outdoor meetings to further awareness of our conservation activities.

During 2019 the Society has undertaken the following activities:

- a. Monitored and protected Raptor nesting sites;
- b. Tree Sparrow purchased bird rings, food and built nest boxes
- c. Donated funds to projects external to WOS
- d. Finished a further Entrust funded Tree Sparrow conservation project
- e. WOS members continued to participate in BTO surveys across Wiltshire.
- f. Produced and published Hobby No 44 the annual 'Wiltshire Bird Report-2017',
- g. Produced and published 4 quarterly editions of WOS News;
- h. Arranged and held indoor meetings with speakers at those meetings and the AGM covering a variety of related topics.
- i. Arranged and held regular outdoor daily birding meetings principally at locations in Wiltshire and surrounding counties, but also with a number of longer trips further afield, targeting both novice and experienced birders..

# Brief statement of the charity's policy on reserves

The Society agreed a reserves policy at this year's AGM as follows ".To ensure the continuity of conservation, monitoring and other activities, which are key to the charity's role and existence, WOS should act in order to ensure that, at all times, unrestricted reserves in General and Designated funds (i.e. excluding Restricted funds) are of an amount roughly equal to one average year's total costs of the society, taking into account the last 3 to 5 years of activity."

It is compliant with that policy.

The principal sources of funding are: Membership fees, HMRC Gift Aid Tax refunds, grants and donations, the provision of bird data records held by the Society to Land Owners/companies who require information on species population and abundance for which a service is charged, other minor donations, the sale of clothing, artwork, Birds of Wiltshire, Hobby and bank interest.

This year, as in previous years, the significant amount of expenditure has gone on the production and postage of Hobby and WOS News, Raptor monitoring and Tree Sparrow conservation. Donations were also made to other conservation projects.

Any surplus funds which are not likely to be needed to pay for activities are placed on deposit to earn interest.

The Society will continue to take advantage of Landfill Communities Funding for biodiversity projects and other Grant sources of income focusing on Raptor Monitoring, Tree Sparrow conservation and other projects.
